I hereby certify that all of the information provided in this application is complete and true to the best of my knowledge. I hereby grant permission to the Woodward County Free Fair to contact my school if necessary and to use my name and likeness in promotional materials in the event that I am selected to receive an award.

All high school seniors in good standing within a Woodward County 4-H club, Woodward County School, or Woodward County School District FFA chapter are eligible to receive this award. Applicants must have verifiable Woodward County Free Fair involvement beyond regular attendance, ex: livestock, equine, creative arts, baked goods, etc. This award will be in the amount of \$500 per semester for one year paid directly to the winner of the award. Before receiving the award fund, the student must have been accepted and enrolled in an accredited college, university, vocation, or technical school as a full-time (12 hours) student. This student must submit proof of enrollment before receiving the first installment of \$500. To receive the second installment of \$500 the winner must document that he/she has maintained a GPA of at least 2.5 for the first semester of school. It will be the sole responsibility of the winner to mail, email, etc. this documentation. The award is to be used by the student to pay for tuition, books, fees, supplies, and incidental expenses associated with the student's attendance at a college, university, vocation, or technical school. No recipient of this award shall be a member of the immediate family of the judging committee. Award applications and supporting documentation are due February 12TH. The winner will be notified by March 8th.
